Re: Records Request

Ms. De Fazio:

Chapter 239 of the Nevada Revised Statutes ("NRS"), specifically NRS 239.0107(1), requires a governmental entity to respond to public records requests within five business days. Accordingly, the Public Utilities Commission of Nevada ("Commission") responds to your October 1, 2018, record request for the following:

- (1) The amount paid to any/all court reporters from 2016 to 2018, along with the projected budget amount for the upcoming biennial for said services.
- (2) COPIES of ALL forms of communication regarding discussion of requesting raising the current mill assessment cap, both internally and to the budget office or any other state agency/department that was communicated with, including but NOT limited to emails, spread sheets, proposed budgets, letters, faxes.
- (3) Any and all communications regarding personnel and financial increases if Question 3 passes, both internally or to any other state agency/department, including but NOT limited to emails, spread sheets, proposed budgets, letters, faxes.
- (4) ALL contributions that Mullens provided to the Governor's Energy Choice Committee to qualify her to be listed as a 'contributor',.
- (5) Current phone list, the DATE of the printout, is to tie into the DATE of it being emailed/responded to said records request. NOT a PRIOR dated print out, that SITS

while you let the time 'run out' to respond to this request. CURRENT implies THAT date on which it was responded to. This is an in person inspection.

The Commission also responds to your October 5, 2018, records request for the following:

Any all communication formats from 8/1/2018 forward, regarding the refusal To acknowledge info@pucnwatchdogs.com, For inclusion on master and service lists, That Blanca Castillo claimed would not listed and no acceptance/response from said Email address.

NRS 239.0107(1)(c)(2) requires that if the Commission has custody of a requested record but is unable to make the public record available by the end of the fifth business day after the date on which the request was received, the Commission may provide notice in writing of the date and time after which the record will be available. The Commission hereby notifies you that it may possess records responsive to your request. However, additional time is necessary to identify and review the requested records due a significant backlog of pending records requests and current staff workload. Therefore, the Commission cannot guarantee that the records that are the subject of this request will be made available to you before November 9, 2018, by 5:00 p.m. The Commission will endeavor to provide the records prior to the aforementioned date; however, if the requested records are not made available to you by November 9, 2018, at 5:00 p.m., you may inquire regarding the status of your request.
